A NOTE FROM OUR LIBRARIAN

It's the festive season but we know it's followed all too quickly by year-end paperwork. So too with the GOOS library. Please help us take an accurate inventory by bringing whatever you have checked out to the January meeting so we can count it. Ron, Roberta and Ann all appreciate your cooperation in making this splendid resource freely available to members. Those of you who have used these materials know how much help they are. If you haven't tried the library, the book list is on our website...make a resolution to 'check it out' in 2014.

Hints from First Rays (www.firstrays.com) "Do I Cut that Old Flower Spike?"

That is probably one of the most frequent questions asked, and like most orchid-related questions, the answer is a resounding "It depends..."

For the most part, once a plant has dropped all of its blossoms, it is safe to cut it off as close to the plant as possible and remove it, but some plants do re-bloom from old inflorescences, so we think the preferred method is to wait and see. If the inflorescence remains green, it may rebloom. If it starts to yellow, it's a goner and can be removed.

Phalaenopsis are sort of a special case. Some will

advise cutting the old spike just below the point that the first (lowest) blossom formed, as that will sometimes "force" the plant to form a branch and bloom again in the short term. We recommend against doing that, as the subsequent blossoms tend to be smaller and fewer, and such forcing can substantially weaken the plant, so much so that it may skip its next blooming cycle or even die.

We still subscribe to the "wait and see" approach for phals. If they are strong enough to rebloom, they will. If not, they won't. If you simply do not like the looks of the bare spike, feel free to remove it, as the plant will grow another when it's good and ready.

REPORTS

Greater Omaha Orchid Society - General Meeting
November 13, 2013, Douglas/Sarpy County Extension Office

7:30 President Stoiber introduced Ron Midgett, New Earth Orchids, Santa Fe, NM, presenting "Let's Play Orchid Trivia!" Following his history as a grower in several geographical areas, *Cattleya Brabantiae* was introduced, using old names. SL Orpetii in Massachusetts was named after his orchid grower, Mr Orpet, in Santa Barbara. New Earth Orchids is located in the High Desert with temps between 65 to 95 degrees, and 340 days of full sun. Blooming seasons may shift by three months; colors may change. Lc Allie's Spice "Peppermint" has been in constant bloom since December. Acknowledgements were noted regarding breeding programs by Nickou, Passander, and Roger Cole, along with Stewart Orchids, Frank Fordyce and Rita Crothers. First, second and third generations of Sc Beaufort were viewed, with C. Luteola x S. coccinea noted as the most influential *Cattleya* parent of the last 30 years ("Elizabeth" AM/AOS and "4N"). Registered in 1963 being bred in 1925/etc. Blc Three Suns "Melinda" HCC/AOS is huge. Moderate sizes were bred. Early minicabs: X loddigesii = Sc Crystelle Smith; difficult to grow; unruly. New directions crossed: Pot Little Toshie. Classic yellows from California (Pot Beaugold; Pot Memorial Gold). Stewarts Yellows are in the background of many today. Produced: sturdy plants that grow well. Pot Beaugold "Apricot Glow" - Blc Pacific Gold x Sc Beaufort: large flower count. Current directions: Pot Memoria Jim Nickou "James" HCC/AOS deep buttercup yellow. Attempts: quick to bloom; 3-6 flowers per stem; vigorous; compact growth habit. Three directions pursued. C. Harace "Maxima" AM/AOS: 8" across; breeds lavenders and purples...until Blc Goldenzzelle. Pot Daniel J. Diver (DEEver) C. Horace "Maxima" AM/AOS x Pot Mem Jim Nickou "James" HCC/AOS great lip color. Sue's Heart will grow in 4" pot blooming 5 times a year. Watermelon Delight; Goldilocks; "Shungetsu" AM/AOS; Pot John Passander "Goldilocks" has 32 blooms. Second Direction: F1 generation of compact *Cattleyas* from SC Beaufort for plant size...bigger than parent. Two F1's crossed together also resulted in Pot Dal's Success "Copper Queen" in orange. Third Direction: Minicatts: Slc Seagull's Apricot "Glorious" in 5" bonsai pot. Red; does not mind high temps. Best efforts include: "Embers" at 5" from "Goldilock" x Glorius" for "Scarlet O'Hara;" "First Timer" HCC-AM/AOS; "Firebrand" AM/AOS: bloomed 9 times in a 4" pot in 6 months. "Outstanding" AM/AOS and "High Noon." Remake of Pot. Apricot Sands resulted in solid red. One more generation out, flowers tended to be without little influence of Beaufort; smaller. Pot Beau's Lemonade and Pot Gold Chiffon: compact; continuous bloom since December. Blc Hwa Yuan Gold "O-2" has 7" flowers x Pot John Passander "Goldilocks" = Pot Santa Fe Gold. Ron concluded that achievements on some plants have compactness, rapid, vigorous growth, reduced bloom time, uniformity of quality, good flower count, and multiple season blooming.

Questions were answered. President Stoiber announced break, raffle sales, and time to view/purchase orchids from New Earth Orchids. Jacque reviewed information about the Holiday Party with sign up sheet passed through the membership. President Stoiber announced the Orchid of the Year Award presented to Roberta, during the show in Dayton, OH. The award was viewed by the membership. No changes to Minutes. Aaron Bugjo reported on the Treasurer's Report with the current balance, and status with copies passed around. Upcoming shows were noted. Show and Tell orchids included interesting stories on "Trick or Treat" blooming for Halloween, and Chocolate Drop, which has been crossed with many other orchids according to Ron Midgett. Tiny, black, and bright red orchids were shown, along with two Jim shared. President Stoiber thanked Ron Midgett and everyone attending. The "Black Orchid" CD with snacks provided by the board is scheduled for January. Raffle drawings for eight donated orchids pleased the winners.

Gift swap will also be included at the Holiday Party with \$2-\$3 gifts.
Meeting adjourned at 9:08 p.m.




region with the opportunity to have their plants evaluated and judged for AOS awards. The Judging Center also hosts guest speakers and other educational opportunities for orchid growers. Judging take place usually on the second Saturday of the month (see the calendar at <http://midamericajudgingcenter.org/Calendar.html>) at the Missouri Botanical Garden, Commerce Bank Center for Science Education (CBCSE), 4651 Shaw Ave, St Louis, MO 63110. Registration of plants for judging begins at 1:00 PM on meeting dates. Cut flowers should be sent to Drs. Craig and Diana Plahn, 1911 Westview Ave., Kirkwood, MO 63122.

All growers are invited to bring their plants to judging. Visitors are welcome to observe the judging process and attend many of the guest lectures.

At the November 11, 2013 judging session 15 plants were submitted for judging. Six awards were given at the session. Photos of the plants, their awards and the owners are shown here.
